Party Form

Conditions of Hire - The Hirer MUST:

- Report to Reception at the Centre on arrival with booking form and booking receipt.
- Agree to the health and safety induction prior to the commencement of the party.
- Sign a food waiver form if bringing own food on site.
- · Not enter the facility area before the designated time booked.
- Ensure the correct ratio of adults to children is adhered to. (please see rules of play for your party below)
- Evacuate the building during a fire alarm. Loss of party or eating time cannot be redeemed.
- Ensure that sensible clothing appropriate to the weather conditions or facility booked is worn, as clothing is not available to hire.
- Ensure that shoes, watches, jewellery and any loose items are removed before children access the play area.
- Take responsibility for any damage or disruption caused by your party.

- Ensure that any infringement of the rules is dealt with in a responsible manner
- Ensure the part ends at the time stated on the booking form, leaving the part area in a clean and tidy state, without any alteration or damage to the party area/facilities provided by CV Life.
- Report any accident or injuries to the Duty Manager/Reception.
- Restrict the consumption of food and drink to the designated area.
- Not allow the use of party poppers, confetti, cocktail sticks, marbles, any glass or crockery items.
- Ensure that they have a list of emergency contact numbers for all children attending.
- Bring the Credit/Debit Card used to make the booking and proof of name and address (for example drivers licence, passport, recent utility bill) to the Centre on the day of the party.
- Be aware that all payments of non-refundable.
